Respected Sir,

I would like to draw your kind attention on the following matter and humbly submits that the land comprised in Khatian nos. 309/1, 309/2, 309/3, 309/4, 309/5, 309/6, 1526, 1527, 1528, 1529, 19/1, and 19/2 and also 1 Kani land tila west side of the house under mouja Jitendranagar, situated Uttar Tulamura Gram Panchayet are undivided joint Properties of the objector & others, this Properties are subject matters of T.S (Partition) 04/2015, T.S (P) 05/2015, of civil judge (Senior division) Gomati District, Udaipur and S.D.M case No. Misc 210/2014, in the Ld. Court S.D.M Udaipur, Gomati Tripura and now T.A. 09/2020 and T.A. - 10/2020 involving the aforesaid land are pending in the Court of district judge, Gomati District, Udaipur and the next date fixed for judgement date 02.09.2022 (Today).

Thus the properties are till undivided and joint mess of possession of the legal heirs of deceased Ashutosh Biswas and Sukhamoy Biswas. And regarding joint mess of this Properties, the Ld. Court of civil judge (Senior division) Gomati district allready passed judgement in TS (P) 04/2015 and TS (P) 05/2015 and it apperent from the judgement and decree dated 25.02.2020 and 26.02.2020 respectively, that there are

Nos. of legal heirs who are entitleed to get compensation as they having interest over the Rubber Plants and others, situated on joint properties, Nilkamal Biswas is mere legal heir alike other legal heirs. It would be clear on perusal of aforesaid judgement.

Thus you the authority can not pass any order making compensation only for single legal heir Nil Kamal Biswas, which is against the law, all the legal heirs deceased Sribash Biswas, Ashutosh Biswas and Sukhamoy Biswas, are entitleed to get share as described in the judgement, Apart that the acquired properties are being sub-judice matter of appeal TA 09/2020 and TA 10/2020 pending in the court of Id. District Judge, Udaipur Gomati, Tripura.

All those matters well aquainted with the Nilkamal Biswas, as he one of the Parties as well as appellant of those cases.

So, suppression of facts amounts to fraud. So aforesaid grounds prompted the objector - claimant for raising this objection — not to make any payment to the Nilkamal Biswas, the one of the legal heirs till partition of the joint properties among the legal heirs of deceased Sribash Biswas, Ashutosh Biswas and Sukhamoy Biswas. Otherwise the objector - claimant one of the legal heir of dt. Ashutosh Biswas will be highly prejudiced.

So it is therefore prayed that the hon'ble authority will be kind enough to take urgent necessary step by passing order stopping the compensation to Nil Kamal Biswas or other legal heirs till partition of the joint properties (as prayed for and obliged there by).
