So my question to you is:-</p> <p>Is He/She eligible for LWP(Leave without pay) Leave for personal reasons upto one or more years, like many govt/public sector organisations. If not eligible then what is the criteria go on leave for one or more years for JEs who have completed 5 years of services.</p>	<p>In POWERGRID there is no provision for LWP (Leave without pay). However, there is a provision for 'Extra-ordinary Leave', which is leave sanctioned under special circumstances without any pay and allowances.</p>
2.	<p>Is there criteria of educational leave for JEs and what is the eligibility for the same also? Like many other organisations provides leave without pay, is there any other way to go on leave for one and more than one years fir personal reasons.</p> <p>Thank you</p>	<p>In POWERGRID there is a provision for grant of study leave for higher studies. The eligibility criteria for grant of study leave is enclosed for reference.</p>

(ii) Grant of Study Leave for Higher Studies.

1.0 Eligibility

- (a) Study Leave is admissible to any regular employee of the Corporation, excluding a trainee/apprentice who;
 - i) Has rendered a minimum of three years' service exclusive of training/apprenticeship period in the Corporation. In the case of deputationists who are subsequently absorbed in the Corporation, the period of deputation will also be taken into account for this purpose.
 - ii) Is not due to retire within 5 years of the date on which he is expected to return to duty after the completion of the course.
 - iii) Is not employed on the contract/deputation/ temporary or casual basis.
 - iv) Is not under suspension and no disciplinary proceedings/vigilance cases are pending against him.
- (b) Study Leave is admissible for a course that;
 - i) Is conducted in India (Grant of Study Leave for course abroad can also be considered, if the course is not available in India).
 - ii) has a direct and close connection with the sphere of duties of the employee.
 - iii) leads to the award of recognised Post-Graduate Degree/Diploma or Doctorate.
