**ORDER**

**Grounds of Appeal**

The Appellate Authority has received an online appeal bearing number **PGCIL/A/E/23/00045** dated **13/09/2023** from Mr. Mantu Kushwaha, (appellant). Earlier, the appellant herein had filed an online RTI application bearing number **PGCIL/R/E/23/00309** dated **26/08/2023**, with the CPIO Corporate Centre. In the instant appeal the appellant has not specified the ground for appeal.

**Order:**

I have seen the RTI application filed by the appellant. I have also perused the reply dated 12/09/2023 sent by the CPIO and other relevant documents. It can be seen that vide aforesaid RTI application, the appellant herein had mentioned certain information related to the recruitment Advt. No. CC/08/2022 (dated 09/12/2022) and his disqualification, however, in his reply the CPIO mentioned that since no query was asked by the applicant, reply cannot be given. Aggrieved by the same the appellant has preferred the instant appeal.

The appellant is basically seeking reason/ justification for his disqualification from the post of diploma trainee. As per appellant he was disqualified at the time of joining as had completed his B.tech.

Be that as it may, in the instant appeal the appellant, in essence, is asking for clarification and justification for his disqualification. In my considered view, this does not fall within the ambit, let alone the definition of information provided under section 2(f) of RTI Act, 2005.

In view of the foregoing submission, the appeal is disposed of.
