(Powergrid) to SPML for Packages TRP-SS-01, TRP-SS-02 & TRP-SS-03 associated with the NE Region Power System Improvement Projects (NERPSIP). The Letter of Award for this contract was accepted by SPML on 4th November 2016. The scope of this contract includes the establishment of 9 new 132/33 KV substations and the strengthening of 7 existing 132/33 substations in Tripura.

Powergrid approved Skipperseil as Sub-Vendor of SPML for the supply of 132/33 Transformers for above project.

In view of the aforesaid, you are requested to kindly provide the undersigned the following information in the form of documents:

5. Whether SPML requested for extension of time for performance of Contract? If yes, please provide the documents submitted by SPML for the grant of time extension.
6. Kindly provide us proof of Liquidated Damages (LD) recovered so far in the contract.
