**ORDER**

**Grounds of Appeal**


The Appellate Authority has received an online RTI Appeal bearing number PGCIL/A/E/23/00050 dated 10.10.2023 from Ms. Renu, (appellant). Earlier, the appellant herein had filed the RTI application bearing number PGCIL/R/T/23/00056, dated 15.09.2023. The instant appeal has been preferred on the ground that the CPIO has provided Incomplete, Misleading or False Information.

**Order:**

I have seen the above mentioned RTI application. I have also perused the reply sent by the CPIO and other relevant documents. The appellant herein in his RTI application had sought the copy of compliance submitted by POWERGRID in response to DPE OM dated 16.03.2023. The copy of the email (vide which MoP forwarded the DPE OM dated 16.03.2023 to CPSEs), was also included in the aforesaid RTI application. CPIO vide reply dated 09.10.2023 had informed that the matter is under review and will be implemented in POWERGRID, based on the direction of the administrative Ministry regarding the same. However, the appellant has preferred this appeal stating that the copy of compliance is still not provided.

It can be seen that CPIO have already provided the information as was available. Section 2 (f) of the RTI Act envisages that only the information which is available is to be provided and if the information sought is not maintained/available the same cannot be provided. In my considered opinion the information has already been provided vide reply dated 09.10.2023.

Accordingly, the appeal is disposed of.
