And how many rupees sanctioned against the said cut / removed of trees in favour of HACHAN ALI S/O Acchad Ali of ward No. 3, Bhagabannagar, Kailashahar.	The copy of the notice (Book no. 07, Page no. 1376) to Hachan Ali detailing the number of trees that were cut down, duly verified by Revenue Inspector of Kailashahar Revenue Circle, TSECL representative, and accepted by the beneficiary themselves in connection with the construction of the 132kV Kailashahar-Dharmanagar TL is attached as Annexure-I . The compensation amount sanctioned for removal of trees in favor of Hachan Ali is ₹1,63,069.00 (Rupees one lakh sixty-three thousand and sixty-nine only).
