#### ORDER

### **Grounds of Appeal**

The Appellate Authority has received an online RTI Appeal bearing number PGCIL/A/E/23/00049 dated 07.10.2023 from Shri Asit Kumar Dash, (appellant). Earlier, the appellant herein had filed the RTI application bearing number PGCIL/R/E/23/00348, dated 18.09.2023. The instant appeal has been preferred on the ground that the CPIO has provided Incomplete, Misleading or False Information.

#### Order:

I have seen the above mentioned RTI application. I have also perused the reply dated 04.10.2023 sent by the CPIO and other relevant documents. To put it succinctly, vide RTI application dated 18.09.2023, the appellant herein had sought information regarding policy which was circulated for the transfer of bond amount from 08.02.2022. CPIO, vide reply dated 04.10.2023, had provided the Inter Office Memo (IOM) dated 05.04.2022 regarding "Transfer of Service Agreement Bond". Not satisfied with the reply, the appellant has preferred this appeal stating that it nowhere endorses that the transfer of bond amount would be implemented w.e.f. 08.02.2022 onwards and not from a previous date and sought the policy letter in this regard.

In my considered opinion, relevant information must be provided to the appellant. The CPIO is hereby directed to provide the information to the appellant within fourteen days of this order.

With the abovementioned observations, the appeal is disposed of.
