This has reference to your RTI application under Reference dated.11.09.2023 addressed to POWERGRID and received in this office on 25.09.2023. The information sought in your application under RTI Act 2005, is as given below.

Query

The crop compensation paid towards acquired the agricultural land bearing the survey number 51/6 acquired by PGCIL for laying the HV lines in Chennanahalli village, Bellavi Hobli, Tumkur Taluk, Tumkur.

Reply

No Land was acquired for the purpose of drawing 765 kV Dharmapuri-Tumkur Single Circuit High Tension Line {PNMTL under TBCB Route} over the Survey Number 51/6 situated at Channenhalli village. The Transmission Line is laid by Power Grid Corporation of India Ltd. in exercise of Right of Way under Section-10 of Indian Telegraph Act, 1882. For the damages caused thereby, as per the available records, the following Crop Compensation was disbursed as detailed below:

1. An amount of Rs. 2,452/- was paid to Sh Chandrashekhar S/o Rajashekaraiah for the crop damaged in Rajashekaraiah's portion of land in Sy No 51/6.
2. An amount of Rs. 52,192/- was paid to Sh Rajashekaraiah S/o Chikkabasappa for the crops damaged in his portion of lands in Sy No 51/6 as well as 51/8.
3. An amount of Rs. 29,057/- Was paid to Smt Gangamma W/o Doddanajiah (Late) for crop damaged in her portion of land in Sy no 51/6 as well as 34/3.
4. An amount of Rs. 5,220 /- Was paid to Sh. Rudresh S/o Smt Neelamma for crop damaged in his portion of land in Sy no 51/6.


