ORDER

Grounds of Appeal

The Appellate Authority has received an online RTI Appeal bearing number PGCIL/A/E/23/00069 dated 28/11/2023 from sh. Vikash Verma, (appellant). Earlier, the appellant herein had filed the RTI application bearing number PGCIL/R/P/23/ 00431, dated 27/10/2023. The instant appeal has been preferred with "Ground For Appeal" mentioned as "Any Other ground".

Order:

I have seen the above mentioned RTI application. I have also perused the reply dated 24/11/2023 sent by the CPIO and other relevant documents. The appellant has preferred this appeal as information provided for serial number A.2 does not match with information provided for serial number A.3 and information related to DPC 2024 (information sought at Sl. No B.2 and B.3) has not been provided.


For information sought at Sl. No A.2 and A.3 of aforesaid RTI application, CPIO has provided the information (details) exactly in the format provided by the applicant. However, the appellant has contended that there is a mismatch in the numbers. Be that as it may, clarification in this regard must be provided.

Further against information sought at Sl. No B.2 and B.3 of aforesaid RTI application, i.e. information related to DPC 2024, CPIO has mentioned that the query pertains to a future event and accordingly answer to this query does not qualify as "information" as per section 2 (f) of the RTI Act, 2005., I find merit in the submission of the CPIO that the information sought does not qualify as "information" as per section 2 (f) of the RTI Act, 2005 as it pertains to a future event. Therefore, the same cannot be provided.

PTO

In view of the foregoing submissions CPIO is hereby directed to provide the clarification regarding mismatch in numbers to the appellant within fourteen days of issuance of this order.

The appeal is, accordingly, disposed of.
