PGCIL is a Government Entity within the definition under Article 21 of the Constitution of India. Hence, PGCIL recruitment advertisement no CC/10/2023 dated 04.11.2023 is a public employment as pr Article 16 of the Constitution of India. It emerges from this advertisement that there is a Service Agreement Bond. Therefore, this Service Agreement Bond cannot be an Intellectual Property. Reply	<p>Service Agreement Bond is an internal document of the Company which is required to be submitted only by a few candidates who are finally selected.</p> <p>It is reiterated that Service Agreement Bond is Intellectual Property of POWERGRID and there is no larger public interest being served in disclosure of the same.</p> <p>Accordingly, the documents sought by the Appellant cannot be furnished under clause 8(1)(d) of the RTI Act 2005.</p>
