### ORDER

#### Grounds of Appeal

The Appellate Authority has received an online RTI Appeal bearing number PGCIL/A/E/24/00002 dated 22.01.2024 from Shri Sharwan Singh Rathore (Appellant). Earlier, the Appellant herein had filed the RTI Application bearing number PGCIL/R/E/23/00504, dated 20.12.2023. The instant appeal has been preferred on the ground that despite the request for the information being made 30 days ago, there has been no response or provision of the requested details up to the present date.

#### Order:

I have seen the above-mentioned RTI application. The Appellant herein in his RTI application has sought the following:


- 1) Please provide the certified copy of list of spare capacity on all PGCIL grid stations in Rajasthan for connectivity to solar and wind power plants;
- 2) What is the bay availability on all the PGCIL Grid stations of Rajasthan for connectivity to solar and wind power plants?
- 3) Also provide the list of upcoming PGCIL Grid station in Rajasthan with details of particular village and location.
- 4) Complete List of existing PGCIL Grid station in Rajasthan with details of name of village, tehsil, and coordinates.
- 5) Complete list of existing PGCIL grid station all over India with detail of spare capacity on the same for connectivity to renewable power plants.

It is understood that CPIO, POWERGRID vide Reply dated 17.01.2024 had provided the details with respect to Queries at S. No. (4) & (5). Further, it was stated that Queries at S. Nos. (1) to (3) pertain to CTUIL and that the same shall be provided by CTUIL separately. The RTI application forwarded by CPIO, POWERGRID was received by CTUIL.

Meanwhile, the Appellant herein preferred an appeal on the grounds of 'no response within the time limit', stating that despite the request for the aforementioned information being made 30 days ago, there has been no response or provision of the requested details up to the present date.

CPIO, CTUIL *vide* Reply dated 06.02.2024 has provided the details with respect to Queries at S. No. (1) & (2). With respect to Query at S. No. (3), it was stated that the same does not pertain to CTUIL but pertains to POWERGRID.

The appeal is accordingly disposed of.
