ORDER

Grounds of Appeal

The Appellate Authority has received an appeal ref. **PGCIL/A/E/24/00004** dated **02/02/2024** from Sh. Rounak (appellant). Earlier, the appellant herein had filed an RTI application bearing reference number PGCIL/R/E/24/ 00008 dated 03/01/2024, reply to which was given by CPIO vide their letter dated 01/02/2024. The instant appeal has been preferred on the ground that the information sought in the application has not been provided.

Order:

I have seen the aforesaid RTI application wherein the applicant had requested to provide certain information regarding SC, ST, OBC and minority associations registered in POWERGRID. I have also perused the reply dated 01/02/2024 wherein the CPIO have communicated that information sought is not related to POWERGRID. Aggrieved by the reply, the appellant has preferred this appeal stating that if the information is not related to POWERGRID then why a meeting was held on 25.12.2023 in Kolkata with the association by POWERGRID. The appellant has also claimed to have attached a supporting document

related to the meeting, however she, seemingly by mistake, has attached an invoice for a medical test (*from Dr Lal Pathlabs*).

Be that as it may, the CPIO is hereby directed to provide clarification to the appellant within fourteen days of this order.

In view of aforesaid, the appeal is disposed of.
