

**NOTIFICATION**

(Issued under section 10 of Balipara/Tirap/Sandiya Frontier Tract Jhum Land Regulation 1947)

WHEREAS, the power and functions of the appropriate authority under the Jhum Land Regulation 1947 vest in Governor, Arunachal Pradesh and which shall be exercised and discharged by him within the state.

AND WHEREAS, it appears to the Governor of Arunachal Pradesh the Land in the locality as described below as required to be taken by the Govt. for Public purpose, namely the purpose of construction of 132kV Transmission Line Ziro (new) to Ziro (PG) from Yachuli to Ziro under comprehensive Scheme for strengthening of T & D system in Arunachal Pradesh.

AND WHEREAS, under section 10 of the Jhum Land Regulation, 1947. Govt. may acquired any Jhum Land Required for any public purpose without formal acquisition proceeding by giving opportunity to those having rights over the land after payment of reasonable compensation.

AND NOW, THEREFORE, Land in locality as described below is hereby acquired under section 10 of the Jhum Land Regulation 1947 for the purpose of construction of 132kV Transmission Line Ziro (new) to Ziro (PG) from Yachuli to Ziro under comprehensive Scheme for strengthening of T & D system in Arunachal Pradesh

Any person who has any objection to the acquisition of the said land for said purpose may file such objection in writing to the Office of the Deputy Commissioner, Lower Subansiri District, Ziro Arunachal Pradesh within 15 (Fifteen) days from the publication of this notification by clearly mentioning the reason for such objection and the Deputy Commissioner in his capacity shall dispose off the same after giving reasonable opportunity for hearing to extinguish the claim of the Land Owners.
