**ORDER**

**Grounds of Appeal**

The Appellate Authority has received an RTI appeal ref. PGCIL/A/E/24/00009 dated 27/02/2024 from Mr. Davinder (appellant). Earlier, the appellant herein had filed an RTI application bearing reference number PGCIL/R/E/24/00034 dated 15/01/2024. The instant appeal has been preferred on the ground that the CPIO has "Provided Incomplete, Misleading or False Information"

**Order:**

I have seen the above mentioned RTI application. I have also perused the reply sent by the CPIO and other relevant documents. The appellant herein in his RTI application had sought certain information related to "*the employees who are on deputation and loan basis to the other department*". CPIO vide reply dated 14/02/2024 had provided the information as was available. It is pertinent to mention here that against the serial number 4 of the RTI application, the CPIO had mentioned that "*Query is not clear*".


The appellant has filed this appeal, contending that the Central Public Information Officer (CPIO) has provided information solely concerning employees who were on deputation, while withholding any details regarding employees who were dispatched to other departments on a loan basis. It can also be seen that the appellant has not given any clarification regarding the information requested in serial number no. 4 of the original RTI application.

In my considered opinion the appellant was given the opportunity to provide clarification regarding the information requested in serial number 4 of the RTI application. In the absence of clarification on the specific information requested by the appellant it is difficult to determine the exact information appellant wants.

However, the information/ clarification related to the employees posted on "loan basis" must be provided to the appellant.

CPIO is hereby directed to provide the information/clarification related to the employees posted on "loan basis" within fourteen days of this order.

In view of the forgoing submission, the appeal is accordingly disposed of.
