 - (f) impact, if any, of use of assets for other business on inter-State transmission of electricity
 - (g) Kindly provide information whether or not the revenue derived from it was taken into consideration in the notified draft MYT regulations or not
 - (e) Kindly provide the names ISTS licensees who are also using their telecommunication business and the amount of revenue earned and shared towards reduction of tariff from the telecommunication business according to the above regulations.
3. Amount of revenue earned by Power Grid Corporation of India Limited (PGCIL) from the other than the transmission business w.e.f 01.01.2008 till 31.03.2023 as per the above regulations including nature of other


