**ORDER**

**Grounds of Appeal**

The Appellate Authority has received an online appeal bearing number **PGCIL/A/E/24/00010** dated **13/03/2024** from Sh. Shashi Prakash Tiwari, (appellant). Earlier, the appellant herein had filed an online RTI application bearing number **PGCIL/R/E/24/00104** dated **29/02/2024**, with the CPIO Corporate Centre. The ground for appeal is mentioned as "Provided Incomplete, Misleading or False Information"

**Order:**

I have seen the above-mentioned RTI application filed by the appellant. I have also perused the reply dated 11/03/2024 sent by the CPIO and other relevant documents. The appellant herein, in his RTI application had sought certain information related to electronic gadget allowance, promotion policy of staff cadre and allowance details of each grade. CPIO vide reply dated 11/03/2024 informed that there is no such allowance (electronic gadget allowance) in POWERGRID. CPIO also informed that there is no staff cadre in POWERGRID and provided the link on POWERGRID website wherein the relevant details of Promotion policy are available. Regarding allowance details of each grade, the appellant was informed

that perks and allowances (under cafeteria system) are paid per month @ 35 % of basic pay.

Not satisfied by the reply, the appellant has preferred this appeal. In essence the appellant in his appeal has clarified that from "staff cadre" he meant various grades like executive, supervisor and workmen and informed that he had gone through POWERGRID website but could not find the information related to promotion and allowances.

In my considered opinion, the requested information has already been provided. The clarification on staff cadre has no bearing on the reply as the link for Promotion policy was already provided by the CPIO. The "allowance details" are also available on POWERGRID website, however as the appellant has shown inability to find the same on POWERGRID website, the CPIO is directed to provide the links, to the appellant within fourteen days of this order.

The appeal is accordingly disposed of.
