ORDER

Grounds of Appeal

The Appellate Authority has received an online RTI appeal bearing number PGCIL/A/E/24/00011 dated 14/03/2024 from Mr. Ambir khan (appellant). Earlier, the RTI application bearing number RTI PGCIL/R/E/24/00127 dated 09/03/2024, from appellant herein, was received by CPIO Corporate Centre. The ground for appeal is mentioned as "Provided Incomplete, Misleading or False Information"


Order:

I have seen the above mentioned RTI application filed by the appellant. I have also perused the reply dated 14/03/2024 sent by the CPIO and other relevant documents. It can be seen that in his RTI application, the appellant herein had sought certain information related to the recruitment of officer Trainee (Law) viz Category wise marks of all candidates "appeared for GD & interview"/ "selected"/ "not selected"/ "in waiting list" etc.

CPIO vide reply dated 14/03/2024 informed the appellant that the individual candidates interview, and GD marks have already been communicated via mail and that rest of the information sought is third party information exempted under section 8(1)(j) of RTI Act.

In my considered opinion the information has already been provided vide reply dated 14/03/2024. Further, the appellant has failed to establish any public interest which would be served in case the information is divulged as the concerned individuals are aware about their respective result.

In view of the foregoing submission, the appeal is accordingly disposed of.
