This has reference to your RTI application under Reference dated.18.01.2024 addressed to POWERGRID and received in this office on 22.01.2024. The information sought in your application under RTI Act 2005, is as given below.

Reply -

- No land acquired by POWERGRID under survey number No.12/2, As per the Chitradurge DC Order Dated.5.6.2017, amount of Rs.1,53,750/- was payable towards corridor compensation (Diminution value of land as per Guidelines) to the rightful land owners. Due to legal dispute in the ownership of the said corridor or land, the amount of Rs.1,53,750/- was deposited towards the said survey number in the Hosadurga Court under OS-22/2018.
- 2. No land acquired by POWERGRID under Survey number 53 & 11. As per the Chitradurga DC order Dated.5.6.2017, an amount of Rs.4,06,250/- for Survey No.53 and Rs.1,30,000/- for Survey No.11 was payable towards corridor compensation (Diminution value of land as per Guidelines) to the rightful land owners. Due to legal dispute in the ownership of said corridor or land, the amount of Rs.4,06,250/- for Survey No.53 and Rs.1,30,000/- for Survey No.11 was deposited towards the said survey number in the Hosadurga Court under OS-22/2018. 56 no of coconut trees in Survey No.53 & 11 for which an amount of Rs.9,13,584 was deposited at Hosadurga Court under OS-22/2018.
