S.No	Query	Reply
1	What is the terms and condition or compensation given to the land owner where the tower installation project is build by power grid company?	Transmission lines in the country are constructed under the ambit of Electricity Act, 2003. POWERGRID has been vested with the powers of Telegraph Authority vide MoP's Gazette Notification dated 24.12.03 under sec 164 of the Electricity Act. The provisions stipulated in section 67-68 of the Electricity Act, 2003 read with section 10 & 16 of the Indian Telegraph Act, 1885 govern the compensation. As per the provision under section 10 (d) of "The Indian Telegraph Act, 1885", all damages assessed and ratified by Revenue authorities are being paid to landowners/ farmers. Due compensation is paid to affected landowners/farmers for damages such as tree, crop, houses and other structure, if affected. Further, land compensation for tower footing & corridor is also paid by POWERGRID as per state specific RoW Compensation notification based on MoP Guidelines of Oct'2015.
2	What is the daily wages of labour and head Mistry?	The minimum wages as notified by central or state government which ever is higher, is being paid.
3	Rates of steel cutting and rod bending per ton ?	Unit rate of these items is not explicitly available as civil item.Reinforcement Steel is inclusive of these works and other such associated works. Further, unit rates of any item as per in-house database is of confidential and sensitive nature, thus sharing any such information is as per Section 8(1)(d) of the RTI Act.
