


	In Investor Presentation November 2022, total transmission lines were 1,364 nos (1,72,982ckm) and in Investor Presentation February 2023 total transmission lines became 1,448 nos (1,73,790 ckm). that means total addition of 808 ckm. however total transmission lines added during the quarter were 84 nos. please provide the following details:	
1.	Name of these 84 numbers of lines (with ckm of each line), which commissioned during Q3 FY 2022-23.	POWERGRID owns and operates mainly ISTS transmission lines all across the country. In many cases the Loop In & Loop Out (LILO) of POWERGRID transmission lines are done by other utility like State Transmission utilities or other private utilities and terminated at their Substations. In such cases, there is no change in overall circuit kM (ckM) of POWERGRID but it results in increase in number of lines. The data i.e. no. of lines & ckM presented during the Investor presentation in February 2023 was based on actual physical assets of POWERGRID including all such LILO (In case of LILO of one line by other utility, the number of lines become two).
2.	details list of assets including each line and substation name with Ckm and MVA capacity of substation till FY 2023- 24.	Data for transmission assets added by POWERGRID is available in public domain i.e. on CEA Website. The link for CEA website is as under: -
