**ORDER**

**Grounds of Appeal**

The Appellate Authority has received an online RTI Appeal bearing number PGCIL/A/E/24/00030 dated 28/05/2024 from Sh. Rahul Meena, (appellant). Earlier, the appellant herein filed the RTI application bearing number PGCIL/R/E/24/ 00226, dated 18/04/2024. The ground for appeal is mentioned as "Provided Incomplete, Misleading or False Information".

**Order:**

I have seen the above-mentioned RTI application wherein the appellant herein, had sought certain information related to recruitment advertisement no. Advt. No. CC/11/2023. I have also perused the reply dated 10/05/2024 sent by the CPIO and other relevant documents. The appellant has preferred this appeal, without objecting to the information provided, requesting basis for not getting his preferred organization despite achieving rank 1 in the ST category.

In my considered opinion, though the Act does not require providing the basis for the information but in the instant case justice would be served if the appellant is provided with the basis behind the selection. The CPIO is hereby directed to provide clarification related to the same within fourteen days of this order.

In view of the foregoing submission, the appeal is disposed of.
