



Reply Q1	<i>Recruitment process is underway. Hence, the information sought cannot be shared at this stage.</i>
Q 2	There is one seat reserved for ST category in CTUIL in the above advertisement and I was having rank one in ST merit and rank 24 in UR merit and according to my ST merit I should be getting CTUIL as it was my first choice. According to UR merit I was not getting CTUIL but according to rule in that case if I am getting my first preference from category merit then category merit should be considered but I got my second preference Powergrid which is allotted as per UR merit without considering ST category and 1st preference. Why this happened? and if there is any rule regarding that please provide me in written.
Reply Q2	<i>This query is interrogative in nature which does not come under the ambit of "Information" under the RTI Act 2005. W.r.t. the rule; please go through the selection process mentioned in the advertisement regarding offer to be issued to the candidates.</i>
Q 3	Give me detail of rank marks scored by the ST candidate whom you allotted the CTUIL seat. I am attaching my result of powergrid and preference filled by me in this.
