Query	Reply
1. Kindly furnish copies of rules/regulations pertaining to condoning the period of unauthorized absence.	As per POWERGRID leave rules, an employee who remains unauthorisedly absent i.e. without sanctioned leave or on expiry of sanctioned leave and does not report for duty within 15 days, shall lose lien on his post and shall be deemed to have voluntarily left the service of the Corporation, without notice. However, if the employee is subsequently able to account for his unauthorised absence to the satisfaction of the Management, the absence may be regularised in the manner deemed fit and covered by rules.
2. Kindly furnish copies of rules/regulations/circulars pertaining to the treatment of period of unauthorized absence (including dies-non).	Same as above. Moreover, as per POWERGRID CDA Rules, "Absence without leave or overstaying the sanctioned leave for more than four consecutive days without sufficient grounds or proper or satisfactory explanation" is misconduct and suitable departmental proceedings as deemed fit by the management is initiated for the said employee.
