Psychometric/ Behavioral assessment shall also be conducted. The results of the test shall be provided to the interview committee for final assessment. Candidates who qualify in the Personal Interview will only be adjudged suitable for empanelment. The criterion for qualifying in interview is minimum 40% marks in interview for Un-reserved/EWS vacancies, and 30% for reserved vacancies.

- I. You are requested to bring the following documents on the date & time mentioned above for verification:-
 - (i) Duly filled Original Personal Resume with attached color photograph.
 - (ii) Print out of your online application in POWERGRID.
 - (iii) Print out of this interview call letter.
 - (iv) Original and self-attested copies of (a) Proof of Date of Birth (b) A valid photo Identity proof (Driving License/ PAN Card/Passport/ Voter ID/ Aadhar Card).
 - (v) Original and self-attested photocopies of your (a) Qualifications (b) Marksheets of each semester/year (c) GATE 2023 Score Card (d) GATE 2023 Admit Card.
 - (vi) If the final marksheet mentions only CGPA, then candidates have to furnish documentary evidence regarding the formula of conversion of CGPA into percentage. In absence of any proof, the formula as mentioned in the detailed notification (i.e. percentage = CGPA obtained/Maximum CGPA *100) shall be adopted.
 - (vii) Original Caste / Disability Certificate in case belonging to SC/ST/OBC (Non- Creamy Layer) category / PwD in the prescribed GOI form issued by Competent Authority along with one attested photocopy thereof. OBC candidates should submit latest OBC(NCL) certificate and will have to submit a declaration regarding their Non-Creamy Layer status.  - (viii) (For out-station candidates) TA claim form, attaching the original bus/railway ticket.
 - (ix) "No Objection Certificate" in case of candidates working in Central /State Govt. Undertaking /Autonomous body. The "NOC" must also state that you will be relieved in the event of your selection for appointment in POWERGRID.
 - (x) Print out of Place/ Region of posting (in case of selection in POWERGRID) in order of preference.
- II. Reimbursement of actual SLEEPER CLASS TO AND FRO RAIL FARE by the shortest route from the address mentioned in the online application or the place from where actually travelled, whichever is nearer, will be admissible on submission of train ticket number/ supporting documentary evidence. In case of travel by bus reimbursement shall be limited to rail fare from the nearest railway station or the bus fare whichever is less, subject to production of bus tickets. No expense will however, be reimbursable for travel, in case the distance covered is less than 30 kms. (Download TA Form from main menu/ your login page).
