Query No.	Why the starting pay scale of non-unionized supervisor is different in cpse whose comes under ministry of power. These CPSE comes under same ministry but payscale is different.  As-NHPC(Navratna) Limited Rs 29600 - 119500  THDC Limited Rs 29200 - 119000  NEEPCO Limited Rs 29300 - 119700  DVC Rs 35400 - 112400 Rs 35400  NTPC(Maharatna) Start from 24000  Powergrid (Maharatna) Rs. 25000-117500
Information 1	The applicant has sought reasoning / justification on why certain practices are in place, this is not covered under the definition of information under Section 2 (f) of the RTI Act, 2005.  However, it may be noted that revision of pay scales w.e.f. 01.01.2017 of board level and below executives and non-unionized supervisors has been implemented in POWERGRID exactly, in line with DPE guidelines dated 03.08.2017.
Query No.	Why maharatna cpse paid less salary as compare to navratna cpse under ministry of power.
Information 2	This is a general statement. No information sought.
Query No.	Why the payscale of workman conflict with non-unionized supervisor which dpe guidliness did not recommend. (para 3.22.7)
Information 3	The applicant has sought reasoning / justification on why certain practices are in place, this is not covered under the definition of information under Section 2 (f) of the RTI Act, 2005.
	However, there is no conflict between the workmen and supervisory pay scales in POWERGRID.
