In respect to RTI query it is informed that the Department of Public Enterprises (DPE) is the nodal department for all the Central Public Sector Enterprises (CPSEs). DPE only coordinates with other Ministries, CPSEs and concerned organizations while fulfilling its role. Furthermore, DPE collects and maintains information in the form of a Public Enterprises Survey on several areas in respect of CPSEs. But requisite information is not available in our records.

In fact, all these CPSEs function under direct administrative control of respective Ministries/Departments. As regarding vacant posts as well as vacancy status/position it is stated that it is totally internal administrative matter of concerned CPSEs and settled in consultation with board of directors of CPSEs and specified Ministries/Departments. Hence, to get requisite information on related matter, if available with different CPSEs, the RTI query is being transferred to CPIOs of all CPSEs to provide information directly to the applicant.
