Sub:- Supply of information under RTI act.

Sir,

I am to intimate you that my authorized advocate Sri Pradeep Kumar Patel had issued a legal notice dtd-12/09/2018 to the Chairman & Managing Director, PGCIL, Corporate Centre, Saudmini, Plot No.-02 Sector -29 Gurgaon-122001 Haryana and others claiming for payment of compensation towards damage caused to my landed property during construction of 400/220KV S/C Jamshedpur- Rourkela transmission line. As per reply to above legal notice of the advocate Sri P K Jena Chief Manager, PGCIL, Jamsedpur has mentioned that adequate compensation has been paid already to the then land owners Sri S. Dungdung, of Bartoli village and Sri Bisra Oram resident of Barmunda vide his letter No.-ER-1/PT/LAW/JSR/453 dtd-15/10/2018.(Sl No.-09)

But it is to be noted that the concerned plot No.-61/242 of Khata No.20/626 and plot No.-156 of Khata No.-20/634 mouza -Bartoli now under Bisra Tehsil of Sundargarh Dist(Odisha), over which the tower No-416 is install and transmission line is passed are my own legitimated landed property. The plot No.-61/242 of Khata No.-20/626 is authorized to Budhuvir ITI, Bartoli and mortgaged to the bank to avail loan for expansion of the ITI. I have purchased the above land from previous land owner Mohit Kumar Pramanik S/o- Allhad Pramanik Khata No.-15, Plot No.-61/242 (2 acres) and Sarju Pramanik W/o- Allhad Pramanik Khata No.-19 Plot No.-156 (5 acres). Since very past 1985 I was farming there on the aforesaid land. There were existed three houses to watch my crops and to carry out agricultural activities. The POWER GRID while carried out the details route survey before commencing the construction of transmission line perhaps overlooked the pre-existed houses. On the above circumstance how the Chief Manager Mr. P.K. Jena identified the aforesaid two persons as the then land owners while he is not the competent revenue authority. Because surrounding to my land there is Govt. land and as I know they have no land there. So it is suspicious and requires to know the real fact.

In the above context I seek some information under RTI Act to produce in the court of law. So kindly furnish the following information :-

1. Whether land is acquired through proper process of land acquisition act and other relevant act.
2. Whether the POWER GRID had issued notice to the land owner for the purpose of installation of tower and transmission of power line.
3. Whether demarcation of land is done through concern tehsil. If yes then kindly furnish the name of RI and Amin engaged for the work.
4. The base on which both Mr. S Dungdung and Mr. Bisra Oram are identified as land owners.
5. Compensation amount paid to Mr. S Dungdung and Bisra Oram.

Dear Sir,

This has reference to above referred legal notices sent by you on behalf of your client pertaining to payment of compensation and removal of tower from the land concerned. Following facts with reference to your query are being furnished for your information;

1. That the POWERGRID is a Government Company registered under the companies Act and the main object of POWERGRID is to transmit the electricity from one region to another region, one state to another state and all over India.
2. That POWERGRID, a Navratna Enterprises of Govt. of India is primarily engaged in power transmission business with the mandate for planning, co-ordination, supervision and control over complete inter-State transmission system and in this way; it is discharging the function which is of public interest and national importance.
3. That in exercise of the powers conferred under Sec. 164 of the Electricity Act of 2003, the Central Government being the "Appropriate Government" has conferred the powers of "Telegraph Authority" upon POWERGRID.
4. That under provision of section 164 of the Electricity Act, 2003, POWERGRID has been authorized to exercise all the powers vested in the Telegraph Authority of Part-III of India Telegraph Act 1885 in respect of the electrical lines and electrical plants established or maintained or to be so established or maintained for the transmission of electricity, for placing and maintaining of electric lines under, over, along or across, in or upon any immovable property for the transmission of electricity.
5. That as per specific provisions contained in The Electricity Act 2003, and the Indian Telegraph Act 1885, neither right, title, possession and interest of Petitioner is denied by POWERGRID


nor POWERGRID has acquired any land of these petitioners, rather right, title and interest of the land continues with the persons concerned, who are land owners of the land in question. POWERGRID has only users' right as provided under The Indian Telegraph Act 1885 for the purpose of construction/maintenance of Transmission line and erection of towers etc.

6. That whatever work (tower/ transmission line) has been done, that is done after due authorization by the Central Govt. as per provisions of the Electricity Act and The Indian Telegraph Act, as stated above.
7. That as per section 10 (d) of Indian Telegraph Act, during the execution of construction work, if any damages caused to property, crops or trees, the same shall be compensated by the executor.
8. That POWERGRID carried out the detailed route survey before commencing construction of transmission line and adopts the most suitable route while considering the techno-economic and environmental facts, thereby avoiding disturbance to the inhabitants of the area and to cause minimum damage.
9. That as per the records available with us the then owner of the land (time when transmission line was constructed) Mr. S. Dung Dung, R/o Bartoli, Bisra, Sundargarh and Mr. Bisra Oram R/o Baramunda, Bisra, Sundargarh had already been adequately compensated for the damages caused during construction of said transmission Line.
10. So for as permission and consent of the then land owner in construction of transmission line and erection of Tower is concerned, that was not required as per statutory provisions. The only issue of compensation for damages was required to be dealt and that had already been made out, vide previous paragraph.

In light of aforesaid, it is to be informed that Corporation would not be able to pay any compensation, since it has already been paid to the people concerned. Further, keeping in mind the technical specification and alignment it is also not possible to remove the Tower from present location as demanded through legal notice.
