



The following employees of Biharsharif Sub-station are allotted quarters in Biharsharif sub-station complex as per details given below w.e.f.../01/01/2018 This allotment is subject to the House Allotment Rules as may be in force from time to time :-

MR. NASIM EQBAL Dum	D-2 (One Room) (Bachelor Accommodation)

The above allotment is subject to the following terms and conditions :-

1. That the rent, if any, for the house allotted to allottee shall be charged as per the rules and the same shall be realised from his earnings every month at source.
2. That the electric and water charges, if any, shall be extra and the amount will be recovered from allottee's earnings every month at source.
3. That allottee will be responsible for the proper up-keep of the house allotted to him and he will not temper with the electric and water meters and other fixtures like doors, windows etc. Allottee shall report the damage or disorder, if any, to the fixtures to the Town Administration/HRM Deptt. in writing.
4. That allottee will not without express permission of the management sub-let the accommodation allotted to allottee or share the same with any other person.
5. That allottee will not maintain cattle, animal or raise poultry in or around the premises allotted to him.
6. That allottee will not raise unauthorised construction in or around the premises allotted to him.
7. That allottee will not keep or store any explosive materials which may endanger the lives and property of the inhabitants in the township.
8. That the refuse or garbage of allottee's quarter shall not be thrown in the open space but shall be deposited in dustbins, pits etc. provided for the purpose.

9. That the allottee will keep the quarter and its surrounding in clean and sanitary conditions so as not cause any hazard into the health of the inhabitants of the surrounding area/township.

10. That allottee or any other inhabitants of the quarter allotted to allottee will not cause any inconvenience or nuisance to his neighbor during the period of occupation of the premises by allottee.

11. That in case of any infection or any contagious disease as small pox etc. which is likely to spread into an epidemic to any inhabitants in his quarter, allottee would immediately report to the Company's Medical Officer and have the patient segregated by removing him to the hospital.

12. That allottee's quarter or premises shall not be used for any unlawful assemblies.

13. That allottee will not allow or permit any undesirable and anti-social elements into his quarter.

14. That allottee shall be only licensee of the house.

15. That when the house is no longer required by allottee for reason or allottee cease to be entitled to it or the allotment is canceled by the management under the rules, shall be responsible for handing over the vacant possession of the house with all the fixtures in fact to any officer of the township.

16. That if at any time for any reason, allottee are allotted other alternate accommodation, he will shift to new premises.

17. That the management shall be at liberty to evict allottee in case of any infringement of rules and regulations of the company.

18. That if allottee fail to comply with allotment rules or fail to comply with the management order for vacating a house, he will be liable for payment of market rent as well as eviction from that quarter.

19. That allottee undertake to abide by the House Allotment Rules, regulations and conditions which are or may be brought into force from time to time by the Management.

20. That at the time of taking the possession of the quarter, you are advised to fill up the proforma as supplied by Supr. (HRM)/Town Admn. Section.

21. You are requested to kindly vacate the existing quarter no..... within three(3) days from the date of occupation of the new house failing which charges shall be levied as per rules.
