02.	Did these towers collapsed on its own or any tools and plants like crane etc. was used to bring down any of these two towers.	Tower under Patna S/S jurisdiction collapsed naturally due to soil erosion by river Ganga.

Sh.Enayat Shameem, JE; TLM/ Patna (Emp.No. 41552) had received message on 12.07.2019, regarding collapse of tower over phone from Sh.Paltu Ghosh, representative of M/s.Transrail Lighting Ltd., working agency at site and the same was communicated to us.

Undersigned is looking after line maintenance work under Patna S/S since last week of April'2019. For tower protection proposal was initiated on dated 30.04.2019 also for protection of tower, Engineer in Chief, Sichai Bhawan, Govt. of Bihar was requested vide ref.no.E/PT/NAB-PAT/W-01 dated 26.04.2019 but due to engagement in General Election-2019, they conveyed over phone their inability to protect the tower. Further Loc.No.129A/0 was in vulnerable condition & was advised by committee to dismantle the said tower for safety & security of the line & accordingly shutdown was approved for destringing & dismantling of Loc.No.129A/0 to save other towers in succeeding spans to avoid cascading effect. Thus tower 129A/0 was isolated even that it could not be saved.
