1.0 This is in reference to your RTI application submitted to CPIO, POWERGRID, Corporate Center, Gurgaon .The information sought by you has been received from POWERGRID concern site and is point wise furnished as below.

2.0 **Point No-1:**

The detailed route map of 400KV D/C Silchar – Hailakandi transmission line is a large piece of document and you may kindly inspect the same at POWERGRID, Silchar office. The address of POWERGRID, Silchar is given below.

Point no-2:

The above transmission line is being constructed as part of the project named "Transmission System Associated with Palatana GBPP and Bongaigaon TPS". The approved estimated cost of the entire project is INR 2144 Crores. Approximate cost of the line as per the price break-up in the original estimate is INR 15.32 Crores.

Point No-3:

The amount released till date against the construction of the 400 kV D/C Silchar-Hailakandi Line is INR 15.64 Crores.

Point No-4:

As per the Indian Telegraph Act'1885 and Indian Electricity Act'2003 acquisition of land is not required for the construction of transmission line.

Point No-5:

Same as above.

Point No-6:

The detailed list of persons who have received cheques for compensation against the construction of 400 kV D/C Silchar-Hailakandi Transmission line is a voluminous document. You may kindly inspect the lists from POWERGRID, Silchar office address of which mentioned above.

Point No-7:

List of LOC Notices is a voluminous document. The same may kindly be inspected at our Silchar office and copies as required may be obtained from our Silchar office.

Point No-8:

No land has been acquired for construction of 400 kV D/C Silchar-Hailakandi Line. However, compensation against surface damage during construction of the transmission lines is paid as per assessment of the District Authorities/Revenue Authorities.

Point No-9:

No land was acquired for construction of Silchar-Hailakandi Line.

Point No-10:

Compensation against trees, crops, huts etc. damaged or removed during construction of the transmission lines are paid to the landowners as per assessment of the District Authorities. Rate list of concerned Government Department is enclosed herewith.
