Sir,

- 1.0 This is in reference to your application dated 13.01.2015 under RTI Act 2005, received on 17.03.2015 through Chief Engineer (C) & CPIO, M/s NHPC Limited.
- 2.0 The information sought by you is furnished point wise as below pertaining to POWERGRID, North Eastern Region.
  - i. The power generated from the Lower Subansiri Hydro-electric project shall be evacuated by two numbers of double circuit transmission lines strung with twin lapwing conductors at 400 kV voltage level. These two lines shall be connected to the  $\pm$  800 KV HVDC Substation at Biswanath Chariali of POWERGRID, which is under construction. The details of the lines are as follows:  
Lower Subansiri-Biswanath Chariali line I: 444 No. towers  
Lower Subansiri-Biswanath Chariali line II: 465 No. towers
  - ii. As per the Indian Telegraph Act'1885 and Indian Electricity Act'2003 acquisition of land is not required for construction of transmission line.
  - iii. Compensation against trees, crops, huts etc. damaged or removed during construction of the transmission lines are paid to the landowners as per assessment of the District Authorities/ Revenue Authorities.
