There is no fixed compensation plan for the affected farmers under Sidli Revenue Circle, Chirag Distt. POWERGRID pays surface damage compensation to the affected farmers/landowners for the standing crops/trees/huts damaged during construction stages. The amount of compensation is worked out based on damages and as per the rate of concerned Government Authority. The related documents involving around 250 pages are available at the following address and the same may be collected personally or by post after depositing the photo copy charges @ Rs. 2 per page in the form of cheque/DD in favour of Power Grid Corporation of India Ltd., payable at Shillong.: CM (Construction HVDC line) POWERGRID Salakati SS, Vill. Harigaon, P.O: Kalipukhari, Dist. Kokrajhar (BTAD), Assam-783369
2	After construction of the transmission towers, who will retain the ownership of the portion of land where the tower is constructed? Who will pay the revenue for that area of land?	As per the Indian Telegraph Act'1885 and Indian Electricity Act'2003 acquisition of land is not required for construction of transmission line.
