Particulars of Information required (IV) Details of Information required:-

The Plot of the land covered by Patta No. 3 Dag No. 54, 57 in Village Soalmari, Mouza Patidarang, Dist. Kamrup, Assam is jointly owned by the undersigned through inheritance from his forefathers with Sri Moniruddin as per item No.7 and 11 of the copy of the Jamabandi (issued from the office of the SDO/Civil/Rangiya) enclosed here with as Annexure-A. My name in the Jamabandi has appeared as Bubul Ali (my nick name) instead of Syed Afazul Ahmed, correction of which has been sought for vide application (attached as Annexure-D) which purportedly is still pending.

On a portion of the above land, Powergrid/Rangiya has erected transmission tower which is evident from the minutes of the meeting held on 29-5-14 drawn by SDO/Civil/Rangiya as attached here with as annexure-B. As per annexure-B(1) item No.2 and annexure-B(4) item No.62 compensation for causing damage to the above land has been paid to Sri Moniruddin alone, ignoring the claim of the undersigned

which was submitted to the concerned authority vide item No. 6 of annexure-B. The copy of the claim is enclosed here with as annexure-C.

By the above deliberate and arbitrary act of the authorities involved, the undersigned has been left dwindled both financially and mentally for causing irreparable loss and infringement of his rights to property. Further it has left a question mark, as to what would happen to the plot of land which the undersigned has lost to Powergrid without having received any amount of compensation.

Therefore the undersigned would like to have the following information under RTI Act/2005 within 30 days as provided in the Act.

- (i) Whether notice was served to all the land owners available in Annexure-A to ascertain the eligibility for compensation before convening the meeting on 29-5-14 as per annexure-B.
- (ii) The procedure/Rule, on the basis of which the recipient of the compensation as per Annexure-B (1) to B(4) were determined.
- (III) Whether a land owner, who resides away from his joint property on account of some obvious reason, loses his rights over the land to the other owner.

(V)Period for which information required:- Nil.

(VI)Other details:- Enclosed as Annexure-B.

- 2.0 As per information received from concerned department, the information against your queries pertaining to POWERGRID, North Eastern Region are as follows:

i)	Whether notice was served to all the land owners available in Annexure-A to ascertain the eligibity for compensation before convening the meeting on 29.05.14 as per Annexure-B.	2 legs of location No.55/0 of 400KV D/C Balipara-Bongaigaon transmission line lies in the land covered by Dag No. 54/57 Patta No. 03 under village Soulmari & Kamalpur Revenue Circle. (earlier Goreswar Revenue Circle). Notices were served to Sayed Maniruddin & sons which was also verified by local Gaon burah & Revenue Authority and then compensation released accordingly to the said land owners.
ii)	The procedure/ Rule, on the basis of which the recipient of the compensation as per Annexure-B (A) to B (4) were determined.	Compensation were determined as decided / verified by the Local Revenue Authority. However, a case WP(C) No. 5098/2014 at Guwahati High court filed by the applicant is subjudice before the Hon'ble Guwahati High court.
iii)	Whether a land owner, who resides away from his joint property on account to some obvious reason, loses his rights over the land to the other owner.	The right of getting compensation by a land owner residing far away from his property is not lost, provided timely proof of possession over the effected plot of land is submitted & the same is verified / witnessed by local Gaon burah & Revenue Authority.
