But the answer received is highly unsatisfactory and the reply is copy of one statement only.

While page no. 2 & 3 of the Annexure sent by you are ridiculous and arouses suspicion as the subject mention on both document are different.

The Schedule and your statements clearly indicates that no underwater repairs are carried out on the 12 nos. of pedestals in 3 nos. of well foundations of Brahmaputra river.

In view of the above, kindly furnish specific answer to my query.

- (2) The contention of Schedule of the work is only surface repairs. There is no indication / specification that underwater repairs are to be executed, clearly state that what was the scope of work? **Whether it was underwater repair or surface repair? Please specify.**
- (3) If any underwater repair are carried out what is the percentage of underwater repair carried out with respect to the total contract value.
