The documents pertaining to your query consists of approx. 125 of pages of A4 size paper. As per RTI Rules 2012, Rule 4, the cost of photocopying charges for the documents will be Rs. 250.00 @ Rs. 2 per A4 paper, which shall be provided after receipt of amount vide demand draft or bankers cheque payable to Power Grid Corporation of India, for providing the documents through post.
b.	Amount of compensation specified as per Government circular and amount of compensation given to the people of the locality till today.	Compensations are assessed based on standing crops/trees (Zirat) damaged during construction of transmission line. Compensation payments are released after joint verification with Revenue Authority and approval from concerned Revenue Circle. Rates of the crops and trees were received from District Agriculture Officer & Forest Department respectively. As on date, Rs. 65,35,979.00 has been granted by Concern Revenue Authority against Zirat damage for different construction activities like foundation, Erection and Stringing in Sarupatgaon and Barpatgaon area.
