- 2.0 It is understood from your application that you have sought certain information pertaining to electrification of Bhowanipur Trimukha, Kurikala, etc. villages west bank of river Singla under Durlabcherra Electrical Subdivision of Karimganj District of Assam under RGGVY.
- 3.0 As per information received from our concerned site/department, the reply to your query is as under:
 - 3.1 The electrification works under RGGVY Scheme in Karimganj district, Assam was implemented by POWERGRID during the year 2009-2014 as consultancy work of Assam Power Distribution Company Ltd. (APDCL) who is the owner of the project. The said project has since been completed by POWERGRID as per sanctioned parameters of approved DPR and the closure proposal of the project has also been submitted to REC/MoP in 2014-2015 by POWERGRID. Hence, the information as required by the applicant may be obtained from M/s APDCL, the owner. A copy of this letter is also forwarded to APDCL with a request to forward the information directly to the applicant.
