As per Indian Electricity Act'2003 as amended time to time, only surface damage compensation is paid to the beneficiaries. The details of surface damage compensation paid to the beneficiaries against the said area duly signed by concerned revenue officials shall be made available on submission of requisite photocopy charges being Rs. 190/- (95 pages x Rs.2 per page) There is no land compensation paid in the said area.
2.	Please furnish what is the rate fixed for the above land acquisition against land & Property?	Only Surface damage compensation is paid as per approved rate of Govt. Of Arunachal Pradesh and the information shall be provided on submission of Rs. 32/- (16 pages x Rs.2 per page) being photo copy charges. Hence, you may deposit the aforesaid amount of Rs. 222.00 (Rs. 190 + Rs.32) through demand draft or bankers cheque payable to "Power Grid Corporation of India Limited", Shillong, being document charge as per RTI Act, 2005.
