ii.	Total cost of the project	The project cost is under finalization however the expenditure towards the project is approx. Rs. 205 Cr.
iii.	The total amount allotted for compensation to beneficiaries and the total amount already disbursed for compensation.	The 400KV Kameng-Balipara TL passess through Assam and Arunachal Pradesh. The compensation amount already disbursed to beneficiaries in Arunachal Pradesh section are as follows: a. Crop compensation: Rs. 3.53 Cr. b. Tree compensation: Rs. 4.82 Cr. c. Hut compensation: Rs. 6.03 Lakh. d. Other properties: Rs. 20.21 Lakh For the Assam section, on receipt of information from the concerned site, the same shall be provided.
iv.	Total Number of transmission tower erected in the west Kameng District, Arunachal Pradesh, with the names of the locations of the tower.	77 Nos. of towers are erected in the West Kameng Dist., Arunachal Pradesh and passing through Bhalukpong, Tippi, Elephant Flat, Sessa Hydel, Saddle & Kimi village.
