Under Chariduar Revenue Circle for transmission of high voltage Power line of Power Grid Corporation. | As per provision of Indian Electricity Act'2003 as amended time to time, there is no provision of Land acquisition for laying of transmission line. Only compensation against surface damages were paid based on compensation assessed as per the following: i. Zirat rate issued by the concerned Revenue Authority in the said case the District Agricultural Officer, Sonitpur. ii. Valuation of tea bushes fixed by the Revenue & DM (LR) Department, Govt. of Assam. iii. Cost benefit analysis (per tree) for rubber issued by Rubber Board for NE Region, as applicable for the respective class of plants. |
