1	What is the amount of compensation assessed for land belonging to the applicant situated at Singri Tea Estate, Tehsil: Borsala, District: Sonitpur, Assam (Myadi Patta No. 325/127) over which 400KVA QUAD BLP-BONG T/L (Tower No. 50/0 to 51/0) is passing through the said land?	400KV D/C (Quad) Balipara-Bongaigaon T/L completed and commissioned on 07.11.2014. As per the applicable rule, As per Indian Electricity Act'2013 as amended from time to time, only surface damage compensation is paid to the beneficiaries for construction of Transmission Lines.
2	Whether any amount of compensation has already been paid?	Yes, as bellow : i) Rs. 61,920.00, Cheque No. 829902, date 28.08.2013 for Crops; ii) Rs. 7,62,548 Cheque No. 315124, date 02.03.2011 for tree
3	Whether any balance compensation amount, if any, to be paid?	Yes
