My marriage is an arranged one, done by Rajababu and his wife Suresh Lakshmi as elders beside my husband. Later family disputes arisen and I filed DVC under section 12(1), 498-A, 3,4 DP Act. against my husband and other family Members.

Among all matters going in court, on 08-05-2019 Mr. G. Raja got his first NBIS order. Police people found that he was not at the given address mentioned in case (i.e. PGCIL quarters, Secunderabad). Later I inquired about him in PGCIL, Secunderabad where one of the Senior UDC gave me wrong information.

Now, Mr. G. Raja Babu got his second NBIS from court on 12-07-2019. In this regard, I need the complete address of Raja Babu to serve the necessary orders from the court.
