1.0 This has reference to your RTI application dated 05.08.19 under RTI Act, 2005 received at CPIO Office NERTS on 13.08.2019.

2.0 As per inputs received from concerned Site, the information pertaining to your query is given below:

Sl. No.	Query	Information
1	Please specify what is the total amount of compensation assessed for land belonging to the applicant situated at Singri Tea Estate, Tehsil: Borsala, District: Sonitpur, Assam (Myadi Patta No. 325/127) over which 400KVA QUAD BLP-BONG T/L (Tower No. 50/0 to 51/0) is passing through the said land.	As per Indian Electricity Act'2013 as amended from time to time, only surface damage compensation is paid to the beneficiaries for construction of Transmission Lines. Thus, as per the law prevailing during the construction of the 400KVA QUAD BLP-BONG T/L, no land compensation is payable.
2	What is the balance amount of compensation to be paid to the applicant and when it will be paid?	A balance amount of Rs.86,263 (Rupees Eighty Six Thousand Two Hundred Sixty Three) against tree compensation is payable to the applicant. As intimated by concerned site office, Demand draft No. 478425 dated 18/Apr/19, payable at Dhekiajuli was drawn in the name of the applicant but when the same was presented before the applicant by POWERGRID Official, the applicant refused to accept it.
