2	Why only one employee at a time allowed to do the shift duty at the substation even in the night shift also	Shift duty is roster based on requirement only.
3	In shift duty roaster also no holiday has been given for the shift duty employee continuous 7 days working even After night shift not getting any rest for the employee	Duty roster are framed as per shift duty norms only. Continuous 07 days or an employee is not rostered.
