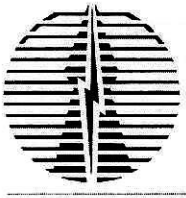

Reply : Compensation details of transmission lines are not maintained against land details viz. Dag, Patta etc. in this office. As such, information against this query cannot be traced.


