2.	What are the special reasons that they had been transferred from NER without completing their 10 years of regular service at NER	Query denied as it does not come under the definition of 'information' as per clause 2(f) of RTI Act, 2005.
3.	How many JEs transferred from NER to another region From 2016 to till now who had recruited during 2019, 2010.	From 2016 till now, 08 nos. of JEs from POWERGRID, who were recruited during 2019, 2010, were transferred from NER to other region.
4.	What is the Priority parameter of the JEs transfer application grant? Means as an example if A, B, C, D 4 JEs(all completed 10 years of regular service at NER) are recruited in the same batch and they have applied for transfer in a different time, then POWERGRID will Grant the transfer request as per there date of application or any other parameter.
