Dear Sir / Madam

In exercise of power vested with TRIPURA STATE ELECTRICITY CORPORATION LIMITED (TSECL) under section-164 of the Electricity Act, 2003 and Section 10 & 11 of the Indian Telegraph Act 1885 and amendment made up-to date thereto, this is to inform you that the proposed 132 KV Kailashhar Dharmraj TK Transmission line will be passing through your land and the properties belonging to you and standing in the required clearance belt of said transmission line will be cut / removed and the trees / crops belonging to you will have to be unavoidably damaged during the construction / election of the line. If so desired by you, the trees / crops so felled / damaged will be handed over to you against recovery of salvage value of the felled trees/crops etc. The compensation for the yield component of the tree(s) so fell and the crop(s) actually damaged will be paid to you as assessed by the Executive Magistrate or authority specified by the Appropriate Government.
