## **ORDER**

The Appellate Authority, Northern Region Transmission System -3, POWERGRID has received an appeal dated 13<sup>th</sup> Dec, 2018 from Shri Ashutosh Dixit, 162 A, Khandauli, Farrukhabad, Uttar Pradesh 209621 under RTI Act, 2005 against the reply given by CPIO (NR-III) (Public Authority) pertaining to his online RTI Request No. 50758 dated 16<sup>th</sup> November, 2018.

After receipt of online appeal from the appellant, relevant papers were pursued and submission of CPIO, NR-III was heard. CPIO, NR-III stated that the information sought by the applicant regarding outstanding payment of sub-contractors or labours of M/s EMCO does not pertain to POWERGRID.

Ongoing through the appeal and submission/ explanation given by the CPIO, it is seen that the appellant has asked for information regarding outstanding list of subcontractors/labours pertaining to execution of 800 kV HVDC Champa-Kurukshetra TL & 765 KV D/C Orai-Aligarh TL packages, awarded to M/s EMCO. In this regard it is opined that the information sought by the appellant does not pertain to POWERGRID and therefore the same has been denied by the CPIO, NR-III (the Public Authority).

The appeal is accordingly disposed off.
