**Grounds of Appeal :**

- 1) Under (1),** I had specifically asked if circular No.7 dtd 23-06-2017 and Circular No.9 dtd 28-06-2017 were made use of for releasing payment of our SSI unit. CPIO has not made any specific mention of the same.
- 2) Under (2),** I had asked if any deliberation/clarification was in writing or any record was created. CPIO's reply does not provide this information.

I had further asked after which circular/deliberation PGCIL decided to release our payment. Information with evidence when common consensus was arrived at.

No evidence has been provided to this effect.

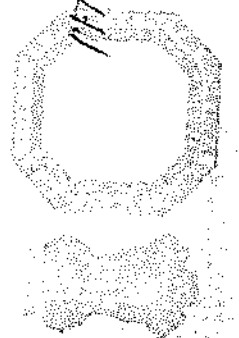
