During the said period, 01 No.(One) contract has been cancelled as the party namely M/s Dayanand who has awarded BLOA vide Ref. No.N1HS/C&M/VEHICLE/BLOA/201/(03)/DTD.03.03.2018 for providing one No. New Vehicle (Bolero Jeep) with Taxi permit has failed to provide 01 No. Bolero Jeep inspite of our reminder, finally vide our Letter dtd.01.05.2018, the said contract has been terminated/cancelled.
