

Subject: Regarding Information sought on RTI application Dt.10.04.2019.

Sir.

This has reference to your RTI Application Dt.10.04.2019 vide which you have sought information under RTI Act-2005. In this regard point-wise information sought by you is as under:

Information to Point No.1: M/s HVPNL vide their letter dated Ch-21/CW-503 dated 08.08.18 has requested POWERGRID for approval/clearance of POWERLINE crossing of their upcoming 132 KV Tajpur to Begga line with existing 765 KV Merrut Bhiwani Line and the approval was accorded by POWERGRID vide letter dated No. N1BI/TLM/Under Crossing/1180 dated 15.11.18 for under crossing for their upcoming 132 KV Tajpur to Begga line with existing 765 KV Merrut Bhiwani Line.

Information to Point No.2: M/s HVPNL submitted a profile for the under crossing with all relevant technical data for clearance from POWERGRID. But the information sought by you is the intellectual property of M/s HVPNL and also comes under the purview of the Trade Secrets of POWERGRID. The information sought cannot be provided by POWERGRID under Section 8(1) (d) of RTI Act-2005. The information can be sought from M/s HVPNL.

Information to Point No.3: This is the only intersecting point where HVPNL 132 KV Tajpur to Begga line crosses with existing POWERGRID 765 KV Meerut-Bhiwani Line and does not cross at any other point.

Information to Point No.4: HVPNL has applied once for approval of clearance as above for POWERLINE Crossing with POWERGRID.

Information to Point No.5: This is to state that position of towers of existing 765 KV S/c Bhiwani-Meerut line is constant and could not be changed. The other line i.e. 132 KV Tajapur-Begga is under construction by M/s HVPNL and further details for said crossing if any may be obtained from HVPNL.
